Fire Districts Boundaries (North Shore) Notice 1980

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Fire Districts Boundaries (North Shore) Notice 1980.

(2) This notice shall come into effect on the 1st day of March 1980.

2. Fire District boundaries—The boundaries of the following Fire Districts have been altered and shall henceforth be as defined in the Schedules hereto:

- (a) the North Shore Fire District being all that area described in the First Schedule hereto;
- (b) the Helensville Fire District being all that area described in the Second Schedule hereto;
- (c) the Warkworth Fire District being all that area described in the Third Schedule hereto;
- (d) the Leigh Fire District being all that area described in the Fourth Schedule hereto;
- (e) the Wellsford Fire District being all that area described in the Fifth Schedule hereto; and
- (f) the Silverdale Fire District being all that area described in the Sixth Schedule hereto.

FIRST SCHEDULE

NORTH SHORE FIRE DISTRICT

ALL that area in the North Auckland Land District, Rodney County, Takapuna City, East Coast Bays City, Birkenhead City, Devonport Borough, and Northcote Borough, bounded by a line commencing at the junction of the line of mean high water of the Okura River and the southern boundary of part Lot 1, D.P. 51511, and proceeding westerly along the southern boundary of part Lot 1, D.P. 51511, and that boundary produced across the East Coast Road to the easternmost corner of Allotment 87, Okura Parish; thence southerly and westerly generally along the eastern and southern boundaries of the aforesaid allotment and the south-eastern boundary of Lot 2, D.P. 70015, and that boundary produced across Bawdens Road and north-westerly along the north-eastern boundary of Allotment 206, Pukeatua Parish, to its northernmost point; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of Allotment 205 and the south-western boundary of Allotment 202 to and south-westerly and north-westerly along the south-eastern and south-western boundaries of Allotment 200 and the south-western boundary of Allotment 199 to Bawdens Road; thence along a right line across Bawdens Road to the southernmost corner of Lot 11, D.P. 65853, and north-westerly along the south-western boundaries of Lots 11 and 10, D.P. 65853, and the south-western boundary of part Allotment 198, Pukeatua Parish, to Postmans Road; thence south-westerly generally along the generally south-eastern side of Postmans Road to and south-easterly along the north-eastern side of S.H. No. 1 to its junction with the eastern boundary of part Allotment 415; thence southerly along a right line across S.H. No. 1 to the northernmost point of Allotment 331, Pukeatua Parish; thence southerly along the western boundary of Allotment 331, Pukeatua Parish, to and south-westerly generally along the right bank of Dairy Stream to its junction with the left bank of the Rangitopuni Stream; thence along a bearing of 225° to the right bank of the Rangitopuni Stream and southerly generally along that right bank to its junction with the left bank of Walsh Creek in Block II, Waitemata Survey District; thence south-westerly generally along that left bank to its intersection with the north-eastern boundary of Allotment 218, Paremoremo Parish, and along the north-eastern and north-western boundaries of that Allotment; thence southerly generally along the generally eastern boundaries of a State Forest being the generally eastern boundaries of Sections 38H, a closed road, 40H, 41H, a closed road, 43H, a closed road, 44H, 45H, a closed road, 52H, 71H, part Sections 53H and 51H, Riverhead Homestead Settlement, and part Allotment 165, Paremoremo Parish, and part Section 51H, Riverhead Homestead Settlement, and part Allotment 69, Paremoremo Parish, and part Section 51H, Riverhead Homestead Settlement, a closed road, Sections 50H, 59H, 65H, Riverhead Homestead Settlement, to the junction of the south-western side of a legal road and the northern boundary of Lot 1, D.P. 15622, in Block V, Waitemata Survey District; thence along a right line across the aforementioned legal road to the westernmost corner of Lot 2, D.P. 15622, and easterly and southerly along the northern and eastern boundaries of that Lot 2 and the last-mentioned boundary produced to the middle of the Wautaiti Stream; thence south-
