FOURTH SCHEDULE

LEIGH FIRE DISTRICT

ALL that area in the North Auckland Land District, Rodney County, bounded by a line commencing at the westernmost corner of Allotment 111, Omaha Parish, in Block XV, Pakiri Survey District, and proceeding north-easterly along the eastern boundaries of Allotments 121 and 102A and part Allotment 51, Pakiri Parish, to the easternmost corner of the last-mentioned allotment; thence north-westerly generally along the north-eastern boundaries of the said part Allotment 51 to and northerly along the eastern boundary of Allotment 45 to and north-westerly generally along the southern side of a legal road to and westerly along the southern boundary of the Wellsford-Leigh road to a point in line with the western boundary of Allotment 38 to and northerly along that boundary and the western boundary of Allotment 37 and its production to the middle of the Pakiri River, all the aforesaid allotments being in Pakiri Parish; thence down the middle of that river to its intersection with a line at a bearing of 315° from the northernmost point of Taumata A; thence south-easterly generally to and along the line of mean high water of the South Pacific Ocean to the westernmost point of a legal road forming the generally western boundaries of Allotment 151, Omaha Parish, in Block II, Rodney Survey District; thence westerly generally along a right line to the northernmost point of part Lot 1, D.P. 63167, and along another right line to the southernmost point of Allotment 178, Omaha Parish (Horseshoe Islands), and along another right line to the northernmost point of Lot 11, D.P. 38580, in Block XV, Pakiri Survey District, and its production to the middle of the Omaha River; thence up the middle of that river to a point in line with the north-western boundary of Lot 1, D.P. 8755, to and south-westerly along that boundary and its production across a legal road and along the northern boundary of part Lot 4, D.P. 8755, to the easternmost corner of part Allotment 34, Matakana Parish, contained in Certificate of Title 1107/155; thence northerly generally along the eastern boundary of that part Allotment 34 to and north-easterly then north-westerly along the generally eastern boundary of Allotment 85 and south-westerly along the northern boundary of the said Allotment 85 to the easternmost corner of Lot 3, D.P. 42172; thence north-westerly along the eastern boundaries of the said Lot 3, Lot 2, D.P. 42172, part Allotments 32 and 33, contained in Certificate of Title 762/125, and part Allotment 33, contained in Certificate of Title 762/122, to the northernmost corner of the last-mentioned allotment, all the aforesaid allotments being in Matakana Parish and situated in Blocks XV, Pakiri, and IV, Mahurangi Survey Districts; thence north-easterly and northerly along the south-eastern and eastern boundaries of Allotments 110A and 110, Omaha Parish, and westerly

and south-westerly generally along the generally northern boundaries of the aforesaid Allotments 110 and 110A to the point of commencement.

WELLSFORD FIRE DISTRICT

ALL that area in the North Auckland Land District, in the Rodney County, bounded by a line commencing at the middle of the Maeneene Stream in line with the southern boundary of Allotment 261, Oruawharo Parish, in Block VIII, Otamatea Survey District, and proceeding easterly to and along that southern boundary and northerly along the eastern boundaries of the said Allotment 261 and part Allotment 259 to the southern side of State Highway No. 1; thence along a right line across that highway to the southernmost corner of part Allotment W75 and north-easterly along the south-eastern boundary of the said part Allotment W75 and its production to the southern boundary of Allotment SW76; thence south-easterly along that boundary, the southern boundary of Lot 1, D.P. 29662, and again along the southern boundary of Allotment SW76 to the westernmost corner of Allotment 78; thence north-easterly, south-easterly, and south-westerly along the north-western, north-eastern, and south-eastern boundaries of the said Allotment 78 to the westernmost corner of Allotment NW79; thence south-easterly along the south-western boundaries of the said Allotment NW79 and Allotment NWM79, and then north-easterly along the south-eastern boundary of the last-mentioned allotment and its production to the southern boundary of part Allotment 63 contained in Certificate of Title 565/170; thence easterly along that boundary and north-easterly along the south-eastern boundary of the said part Allotment 63 to the south-western boundary of Allotment NW58; thence south-easterly along that boundary and the south-western boundary of Allotment M58 to the north-western boundary of Allotment 69A; thence easterly generally along the generally northern boundary of the said Allotment 69A to the south-western boundary of Lot 3, D.P. 25558; thence south-easterly along that boundary and its production to and along the south-western boundary of Lot 5, D.P. 25558, and its production to the north-western boundary of Allotment 66; thence north-easterly and south-easterly along the north-western and north-eastern boundaries of the said Allotment 66 and the production of the last-mentioned boundary to the north-western boundary of Allotment 67; thence easterly and south-westerly generally along the generally northern and south-eastern boundaries of the said Allotment 67 and the south-eastern boundary of Allotment 85, all the aforesaid allotments being in Oruawharo Parish and situated in Blocks VIII, Otamatea, and IV, Pakiri Survey Districts, to the westernmost corner of Allotment W71 Arai Parish; thence south-easterly along the south-western boundary of the said Allotment W71 to and south-easterly and easterly along the south-western and southern boundaries of Allotment 117 and its production to the eastern side of a legal road; thence southerly along that eastern side and easterly generally along the northern side of Pools Road to a point in line with the north-eastern boundary of Allotment S45; thence to and south-easterly generally along the generally north-eastern boundary of the said Allotment S45 to the north-western boundary of Section 9, Block VIII, Pakiri Survey District, all the aforesaid allotments being in Arai Parish and situated in Blocks IV and VIII, Pakiri Survey District; thence north-easterly along the said north-western boundary and south-easterly along the north-eastern boundary of the said Section 9 and its production to the middle of the Waitapu Stream and up the middle of that stream to a point in line with the eastern boundary of Section 8S, Waiteitei Settlement; thence southerly to and along that boundary and that boundary produced across Tomarata - Waiteitei Road to and south-easterly along the north-eastern boundary and south-westerly along the south-eastern boundary of the said Section 8S to the northernmost point of part Pakiri No. 1 as shown on D.P. 1987; thence south-easterly along the north-eastern boundary and westerly along the southern boundaries of the said part Pakiri No. 1 to the right bank of the Whangaripo Stream; thence south-easterly generally along that bank to a point in line with the eastern boundary of Lot 7, D.P. 84827, in Block IX, Pakiri Survey District; thence along a right line to the easternmost corner of that Lot 7 and south-easterly generally along the generally south-western side of Wellsford - Leigh road to its junction with the northern side of a legal road in Block XIII, Pakiri Survey District; thence westerly generally along the generally northern side of that legal road to a point in line with the eastern boundary of Lot 1, D.P. 84828; thence southerly to and
