

77859, and along a right line crossing another public road to and along the northern boundary of Lot 1, D.P. 75508, and that boundary produced to the middle of the Wainui Stream in Block II, Waiwera Survey District, all the aforesaid Allotments being of Waiwera Parish; thence north-easterly generally down the middle of that stream and down the middle of the Waiwera River to a point due north of trig. f near the Waiwera River Mouth in Block III, Waiwera Survey District; thence due south to and southerly then easterly generally along the line of mean high water of the Hauraki Gulf, crossing the mouths of all rivers and inlets, to its junction in Block I, Tiritiri Survey District, with the western boundary of that part Lot 1, D.P. 2187, taken for defence purposes by *New Zealand Gazette*, 1960, page 407; thence easterly generally along the generally southern boundary of the land taken for defence purposes, *New Zealand Gazette*, 1960, page 407, and the generally north-western, the north-eastern, and south-eastern boundaries of the land taken for sanitary works, *New Zealand Gazette*, 1979, page 2090, and again along the generally southern boundary of the land taken for defence purposes, *New Zealand Gazette*, 1960, page 407, to its junction with the line of mean high water of the Hauraki Gulf; thence south-westerly generally along the line of mean high water of the Hauraki Gulf, crossing the mouths of rivers and inlets, to the point of commencement.
