# KEITH HOLYOAKE, Governor-General A PROCLAMATION

PURSUANT to section 63B (1) of the Forests Act 1949 (as substituted by section 19 of the Forests Amendment Act 1976), I, The Right Honourable Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby set apart the State forest land described in the Schedule hereto as State forest park to be known as Kaimanawa State Forest Park.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL PURSUANT to the Agricultural and Pastoral Societies Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. (1) This order may be cited as the Rotorua Agricultural and Pastoral Association Incorporated Authorisation Order 1980.
- (2) This order shall come into force on the day after its notification in the Gazette.
- 2. The Rotorua Agricultural and Pastoral Association Incorporated, duly incorporated under the Agricultural and Pastoral Societies Act 1908, is hereby authorised to sell those lands derived from the Crown set out in the Schedule hereto.
