

## FIRST SCHEDULE

SITUATED within Matamata Borough:

No. 27 State Highway (Mangatarata-Tirau): from Jellicoe Road to the southern boundary of Matamata Borough; and from the northern boundary of Matamata Borough to Ratcliffe Street.
