Commerce Act 1975

1. Notice is hereby given that the Commerce Commission has received, on 26 September 1980, a report from the Examiner of Commercial Practices relating to the proposed takeover by Fletcher Holdings Ltd. of Carter Holt Holdings Ltd. In his report the Examiner concludes with the following recommendation:

I recommend that the Commission make an order in terms of section 78 of the Act prohibiting the takeover of Carter Holt Holdings Ltd. by Fletcher Holdings Ltd.

I further recommend that the Commission make such orders or impose such requirements under section 78 which will have the effect of prohibiting the appointment to the board of directors of Carter Holt Holdings Ltd. of any person from the Fletcher group of companies, or of any nominee of the Fletcher group who is not acceptable to the board of Carter Holt Holdings Ltd.

The Commission will conduct an inquiry into this matter as required by section 76.

2. On 11 and 14 June 1980 the Commission advertised calling for party applications to this proposed hearing. All applications received in response to this notice have been considered by the Commission. A list of the persons admitted as parties is available on request from the Executive Officer at the address at the foot of this notice. This list also shows the basis on which they have been admitted.
