A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, the Right Honourable Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for road, and shall vest in the Waimairi County Council, as from the date hereinafter mentioned; and I also declare that this Proclamation shall take effect on and after the 16th day of October 1980.

CANTERBURY LAND DISTRICT

ALL that piece of land containing 71 square metres, situated in Block X, Christchurch Survey District; being part Lot 1, D.P. 8439; as shown on plan S.O. 15212, lodged in the office of the Chief Surveyor at Christchurch, and thereon marked 'A'.
