

over, and out of the areas described in the First Schedule hereto without payment.

4. Nothing in this order shall authorise the Authority to do or cause to be done anything repugnant to or inconsistent with any law relating to the Customs or with any regulation of the Minister of Customs or with any provision of the Harbours Act 1950, or its amendments or any regulations made thereunder that are or may hereafter be in force.

5. The rights, powers, and privileges conferred by this order shall not apply to those portion of the area described in the First Schedule hereto required for securing the shore end of any telegraph cables that are at the commencement of this order or may at any time subsequently be laid down within the area described in the First Schedule hereto.

6. The Authority may enclose any part or parts of the area described in the First Schedule hereto for the purpose of holding sports meetings, or games and may, by bylaw fix a charge for the admission to any such enclosed part or parts; provided that the number of days for which any particular part of that area described in the First Schedule hereto is enclosed shall not exceed six days in any one calendar year.

7. Nothing in this order shall authorise the Authority to remove or cause to be removed from the area described in the First Schedule hereto any stone, shingle, sand, boulders, silt, mud, shell or other material without the consent in writing of the Minister being first obtained.

8. Subject to the provisions of section 8A of the Act, the Authority for and within the waters of the area described in the First Schedule hereto—

- (a) May by bylaw, made by the Authority, do anything which a harbour board may do by bylaw under section 323 of the Act.
- (b) May jointly appoint harbourmasters and their own and other officers and define or limit their powers or duties.

9. The powers, functions, duties and authorities conferred on the authority by this order may at any time be resumed by the Governor-General, without payment of any compensation whatever, on giving the Authority at least six calendar months' notice in writing. Any such notice shall be sufficient if given by the Minister and delivered at or posted to each council at the last known address of the council in New Zealand.
