Import Control Exemption Notice (No. 20) 1980

In the notice with the above heading published in the New Zealand Gazette, 4 December 1980, No. 141, p. 3819, for "2. Goods of the classes specified and for the purposes of the Customs Tariff falling within the tariff items shown; imported from and being the produce or manufacture of any country, are hereby exempted from the requirement of a licence under the said regulations." read "2. Goods of the classes specified and for the purposes of the Customs Tariff falling within the Tariff items in the First Schedule hereto, imported from and being the produce or manufacture of any country, are hereby exempted from the requirement of a licence under the said regulations." and for "4. The exemption from the requirement of a licence under the said regulations in respect of the goods of the classes set forth in the Second Schedule hereto, included in the exempting notice shown in the Second Schedule are hereby withdrawn." read "4. The exemption from the requirement of a licence under the said regulations in respect of the goods of the classes set forth in the Third Schedule hereto, included in the exempting notice shown in the Third Schedule is hereby withdrawn."
