

NINTH SCHEDULE

ORMONDVILLE FIRE DISTRICT

ALL that area in the Hawke's Bay Land District, Dannevirke County, and Waipawa District, bounded by a line commencing at the intersection of the middle lines of the Mangatewainui Stream and the Manawatu River in Block XIII, Takapau Survey District, and proceeding northerly generally along the Mangatewainui Stream to a point in line with the south-eastern boundary of Suburban Section 125, Norsewood; thence north-easterly to and along that boundary and its production to the north-eastern side of Garfield Road; thence north-westerly along that side to the southernmost corner of part Section 13A, Block V, Takapau Survey District; thence easterly along the southern boundaries of part Section 13A and Sections 10A and 9A, Block V, Takapau Survey District, and the production of the last-mentioned boundary to the middle of the Makotuku Stream; thence north-easterly along that stream to a point in line with the south-western boundary of part Suburban Section 151, Norsewood; thence south-easterly to and along that boundary, and the south-western boundaries of Suburban Sections 152, 153, and 154, Norsewood, to the southernmost corner of Suburban Section 154, Norsewood; thence along the south-eastern and north-eastern boundaries of the Suburban Section 154, Norsewood, to a point in line with the south-eastern boundary of Suburban Section 84A, Norsewood; thence north-easterly to and along that boundary and the south-eastern boundaries of Suburban Sections 85, 85A, 85B, 86, 86A, 87, and 87A, Norsewood, to the westernmost corner of Section 1, Block V, Takapau Survey District; thence south-easterly along the south-western boundary of the said Section 1 to McLeod Road, along a right line to the westernmost corner of Section 8, Block V, Takapau Survey District, and along the south-western boundary of the said Section 8 to its southernmost corner; thence north-easterly along the south-eastern boundary of the said Section 8 and its production to the middle of the Kahu Tetae Atua Stream; thence south-easterly generally along that stream and its production to the middle of the Manawatu River; thence north-westerly generally along that river to a point in line with the north-eastern boundary of Otawahao A9No.2B; thence south-easterly to and along that boundary to the westernmost corner of Otawahao A6F2 and westerly along the northern boundary of Otawahao A6F2 and its production to the generally south-eastern side of the Palmerston North-Gisborne Railway; thence south-westerly generally along that side to the middle of the Waikoukou Stream; thence southerly generally along that stream to a point in line with the southern boundary of Lot 22, D.P. 8648; thence easterly to and along that boundary, the southern boundaries of Lot 21, D.P. 8648, and Lot 2, D.P. 1789, and the production of the last-mentioned boundary to the eastern side of the Rangitoto Road, thence southerly along that side to the southern boundaries of part Lot 1, D.P. 1925; thence easterly along those boundaries to the western boundary of Lot 1, D.P. 2162; thence southerly along that boundary to the right bank of the Mangapurakau Stream; thence along a line at right angles to that bank to the middle of that stream; thence south-easterly generally along that stream to a point in line with the north-western boundary of Section 2, Block XI, Takapau Survey District; thence south-westerly to and along that boundary and south-easterly along the south-western boundary of the said Section 2 to the north-western boundary of Section 25, Block X, Takapau Survey District; thence south-westerly along that boundary to the north-eastern boundary of Section 26, Block X, Takapau Survey District; thence north-westerly along that boundary to the northernmost corner of the said Section 26; thence south-westerly along the north-western boundary of the said Section 26 to Te Uri Road, along a right line to the northernmost corner of Section 22, Block XIV, Takapau Survey District, and along the north-western boundaries of Sections 22 and 24, Block XIV, Takapau Survey District, to the north-eastern boundary of Section 15, Block XIV, Takapau Survey District; thence north-westerly along that boundary to Paeroa Road, along a right line to the easternmost corner of Section 31, Block XIV, Takapau Survey District, along the north-eastern boundary of the said Section 31 to Donghi Road, along a right line to and again along the north-eastern boundary of the said Section 31 and along the north-eastern boundaries of Waikopiro B2 and part B1, and the production of the last-mentioned boundary to the middle of the Manawatu River; thence south-westerly generally along that river to the point of commencement.

Fire District Boundaries (Marlborough) Notice 1980

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Fire Districts Boundaries (Marlborough) Notice 1980.

(2) This notice shall come into effect on the 1st day of March 1980.

2. Fire District boundaries—The boundaries of the following fire districts have been altered and shall henceforth be as defined in the Schedules hereto.

- (a) the Blenheim Fire District being all that area described in the First Schedule hereto;
- (b) the Havelock Fire District being all that area described in the Second Schedule hereto;
- (c) the Seddon Fire District being all that area described in the Third Schedule hereto; and
- (d) the Picton Fire District being all that area described in the Fourth Schedule hereto.

FIRST SCHEDULE

BLENHEIM FIRE DISTRICT

ALL that area in the Marlborough Land District, County of Marlborough, and Borough of Blenheim, bounded by a line commencing at the intersection of the middle of the Wairau River Diversion and the sea coast in Block VIII, Cloudy Bay Survey District, and proceeding southerly along the sea coast to the middle of the mouth of the Wairau River; thence southerly along a right line to the intersection of the north-western boundary of the Marlborough Harbour Board Endowment and the north-eastern boundary of part Section 8, Opawa Registration District, in Block I, Clifford Bay Survey District; thence generally south-easterly and north-westerly along the boundary of the Marlborough Harbour Board Endowment to a point on the left bank of the creek between Upper Lagoon and Big Lagoon in line with the right lined south-western boundary of Section 5, Wairau Registration District; thence south-westerly along a right line to the easternmost corner of the land shown on D.P. 112 in Block II, Clifford Bay Survey District; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of that land and the production of the last-mentioned boundary to a point in line with the south-eastern boundary of part Section 17, Opawa Registration District in Block II aforesaid; thence south-westerly to and along that boundary and its production to the southern side of the Main North Railway, and continuing south-westerly along the said south-eastern boundary to the southernmost corner of the southern portion of that part Section 17; thence north-westerly along the south-western boundary of that section to the south-eastern boundary of part Section 26, Block 2, Omaka Registration District; thence south-westerly along that boundary to the northern boundary of the southern part of Lot 1, D.P. 3687; thence westerly along that boundary and its production to the middle of Puka Puka Creek; thence down the middle of that stream and its production to the middle of Seventeen Valley Stream; thence up the middle of that stream to a point in line with the middle of an unnamed stream which forms the south-eastern boundary of Section 14, Block IX, Taylor Pass Survey District; thence to and up the middle of that stream to the north-eastern boundary of Section 14 aforesaid; thence north-westerly along that boundary to the northernmost corner of that section; thence south-westerly along the north-western boundaries of that section 14 and Section 15, Block IX, Taylor Pass Survey District, to the northern side of Maxwell Pass Road; thence westerly along the northern side of that road to the eastern side of Taylor Pass Road; thence northerly along the eastern side of that road to a point due east of the southernmost corner of Section 16, Block IX, Taylor Pass Survey District; thence due west to that corner; thence north-westerly along the south-western boundary of that section and its production to the western boundary of Section 37, Block III, Taylor Pass Survey District; thence southerly along that boundary to the western boundary of part Lot 1, D.P. 780, within certificate of title 27/175; thence southerly along that boundary to a point due east of the north-eastern corner of Section 49, Block I, Omaka Registration District within Lot 2, D.P. 1887; thence due west to that corner and westerly along the northern boundary of the said Section 49 and Section 67, Meadowbank Run, Omaka Registration District within Lots 1 and 2, D.P. 1887, to the northern side of the public road between Lot 1 and part Lot 4, 1887; thence westerly along
