Bylaw Regulating Heavy Traffic Loadings on the Gates of Haast Bridge on No. 6 State Highway (Blenheim-Invercargill)

PURSUANT to the National Roads Act 1953 and the Transport Act 1962, the National Roads Board makes the following bylaw.

BYLAW

1. This bylaw may be cited as National Roads Board Bylaw 1980 No. 1.

2. This bylaw shall come into force on the day after its publication in the Gazette.

3. In this bylaw the expression "heavy motor vehicle" has the meaning assigned to it in the Transport Act 1962.
