THIRD SCHEDULE

CONDITIONS

1. Her Majesty or the Governor-General and all officers in the Government service acting in the execution of their duty shall at all times have free ingress, passage, and egress into, over and out of the areas described in the First Schedule to this order without payment.

2. Nothing herein contained shall authorise the Council to do or cause to be done anything repugnant to or inconsistent with any law relating to the Customs, or with any regulation of the Minister of Customs, or with any provision of the Harbours Act 1950, or its amendments, or any regulation made thereunder that are or may hereafter be, in force.

3. The rights, powers, and privileges conferred by this order in council shall not apply to those portions of the foreshore required for the securing of the shore end of any telegraph cables that are at present or may be at any time laid down within the area described in the First Schedule to this order.

4. The Council may enclose any part or parts of the foreshore described in the First Schedule hereto for the purpose of holding athletic sports or games and may, by bylaw, fix a charge for admission to such enclosed part or parts; provided that the total number of days on which such enclosures are made shall not exceed 6 in any 1 year.

5. Nothing herein contained shall authorise the Council to remove or cause to be removed any stone, sand, shingle, or shells without the consent of the Minister being first obtained.

6. Suitably worded signs shall be erected at the main public access ways to the foreshore and waters described in the First and Second Schedules to this order indicating that control has been granted to the Council, pursuant to sections 8A and 165 of the Act and that bylaws are in force.

7. Subject to the provisions of section 8A of the Act, the Council for and within the area of water described in the Second Schedule to this order:

(a) May by bylaw do anything which a harbour board may do by bylaw under section 232 of the Act;

(b) May appoint officers to police the bylaws and define or limit their powers and duties.

8. All money received by the Council in respect of the foreshore and waters described in the First and Second Schedules to this order, in exercise or performance of the powers, functions, duties, and authorities conferred on it by this order, shall, subject to the deduction of any expenditure incurred by the Council in exercise or performance of those powers, functions, duties, and authorities conferred on it by this order, shall be applied to the improvement of facilities on or in respect of the foreshore and water activities and not otherwise.

9. Bylaws made by the Council under the authority of this order in council shall not come into force until they have been approved by the Minister, by notice in the *Gazette*.

10. The said rights, powers, and privileges may be at any time resumed by the Governor-General without payment of any compensation whatever, on giving to the Council 6 calendar months notice in writing. Any such notice shall be sufficient if given by the Minister and delivered at or posted to the last known address of the Council in New Zealand.
