S. 20914 produced, to the western side of a public road; thence generally north-westerly along that roadside, and the north-eastern boundary of part Kaitimako J2 and L Block, to the south-eastern boundary of Te Onepu Block, situated in Block XIV, Tauranga Survey District; thence along that south-eastern boundary to the north-eastern side of Kaitimako Road; thence along a right line, to the northernmost corner of part Kaitimako C Block, and along the north-western boundary of that block, to and generally southerly along the right bank of the Kaitimako Stream, to a point in line with the southern boundary of part Lot 5, D.P. 14524; thence to and along that boundary and its production, to the western side of Ohauti Road; thence northerly along that roadside to the southern boundary of Lot 3, D.P. 36314; thence westerly and northerly, along the southern and western boundaries of that lot, and northerly along the western boundary of Lot 3, D.P. S. 5865, to the south-eastern corner of Lot 1, D.P. S. 22615; thence northerly and south-westerly, along the eastern and northern boundaries of that lot, and the southern boundaries of Lots 2 and 1, D.P. S. 8986 to the western boundary of the last-mentioned lot; thence northerly along that boundary, to the southern side of Poeke Road; thence westerly along that roadside, to the generally northern side of the Tauranga - Te Maunga Motorway; thence generally westerly along that side to the south-eastern boundary of part Lot 3, Deeds Plan 239; thence along that boundary and north-westerly along the north-eastern boundary of the said part Lot 3, and along that last-mentioned boundary produced, to the north-western side of Cameron Road; thence generally south-westerly along that roadside to the northern side of No. 29 State Highway; thence generally westerly along that roadside, to the left bank of the Kopurererua Stream; thence generally north-easterly along that left bank, to the south-western side of Wylie Street situated in Block XIV, Tauranga Survey District; thence north-westerly generally along that Street side, and its production, to and along the southern boundaries of Allotments 784 and 785, Parish of Te Papa, to the westernmost corner of the last-mentioned allotment; thence generally north-easterly along the north-western boundaries of Allotment 785 and part Allotment 524, Parish of Te Papa, Lot 7 D.P. S. 24352, and again along the said part Allotment 524 to the left bank of the Kopurererua Stream; thence generally northerly along that left bank, to the northern boundary of Lot 3, D.P. S. 100; thence along that boundary and its production, to the north-western side of Cambridge Road; thence generally north-easterly along that roadside to the easternmost corner of Lot 5, D.P. S. 12630; thence northerly and westerly along the eastern boundary of that lot, and the eastern and northern boundaries of Lot 4, D.P. S. 1263, to the western boundary of part Lot 2, D.P. 10920; thence generally northerly along that last-mentioned boundary, to the south-western side of No. 2 State Highway, along a right line, to and along the north-western boundary of Lot 2, D.P. 23397, to and along the north-eastern boundary of part Lot 1, D.P. 23397, and the eastern boundary of Lot 1, D.P. 25114, to the point of commencement.

BOUNDARIES OF TAURANGA COUNTY

ALL that area in the South Auckland Land District, containing 2020 square kilometres, more or less, bounded by a line commencing at a point in Block I, Katikati North Survey District, on the sea coast of the Bay of Plenty, known as Te Ararimu, being, the south-eastern corner of Lot 19 D.P. S. 22035, and proceeding generally south-easterly along the seashore of the Bay of Plenty to the north-eastern corner of Waewaeikitia 1, situated in Block IV, Waihi South Survey District; thence southerly along the eastern boundary of Waewaeikitia 1, along a right line to and along the eastern boundaries of Waewaeikitia Urupa and Waewaeikitia No. 2B, 2A and 3, along a right line to and along the eastern boundary of part Lot 1, D.P. 8636, along a right line across No. 2 State Highway, to and along the eastern boundaries of part Lot 2, and Lots 4 and 6, D.P. 35929, Lots 15, 14, part 13 and 11, D.P. 8636 to the north-eastern corner of Section 9, Block VII, Waihi South Survey District; thence southerly along the western boundary of Lot 1, D.P. S. 19141 and

its production to and along the eastern boundaries of part Tahunarua 3A and part Section 6, Block VI, Waihi South Survey District to the south-eastern corner of the last-mentioned section; thence southerly along a right line between that south-eastern corner and the north-western corner of part Section 15, Block XI, Rotoma Survey District, to its intersection with the northern boundary of Section 12, Block VII, Rotoma Survey District; thence generally north-westerly along that boundary to a point on the eastern side of Manawahe Road, in line with the northern boundary of Section 8, Block VII, Rotoma Survey District; thence westerly to and along that boundary, the northern boundary of Section 15, Block VI, Rotoma Survey District, the northern end of Hamilton Road, the northern boundary of Section 18, Block VI aforesaid, and the last-mentioned boundary produced to the middle of Pongakawa Valley Road; thence generally north-westerly along the middle of that road, and the middle of Rotoehu Road to a point in line with the northern boundary of Section 2, Block I, Rotoma Survey District; thence westerly to and along that boundary and its production to the middle of the Pararake Stream; thence southerly up the middle of that stream to the northern boundary of Rotoiti 5B2; thence north-westerly along that boundary and the northern boundaries of Rotoiti 5B1 and Tokerau A4, to the eastern boundary of Kaikokopu Road along a right line to and again along the northern boundary of Tokerau A4, along the northern boundary of Tokerau A2 to the western boundary of Maniatutu Road; thence north-westerly along a right line, to the easternmost point of Tokerau A1B; thence proceeding north-westerly along the northern boundary of Tokerau A1B and Rotoiti 3V 2A, the northern end of Lichensteins Road, the northern boundary of part Rotoiti 3V, and the last-mentioned boundary produced to the middle of Pokopoko Stream; thence northerly down the middle of that stream to a point in line with the northern boundary of part Waipapa 1D; thence westerly to and along that boundary and its production to the middle of No. 33 State Highway; thence generally northerly along the middle of that State Highway to a point in line with the north-eastern boundary of part Okere 1E; thence north-westerly to and along that boundary, and its production, to the middle of Kaituna River; thence northerly down the middle of that river to a point in line with the southern boundary of Lot 1 D.P. S. 12978; thence westerly to and along that boundary and the southern boundary of part Section 1, Block XIV, Maketu Survey District and its production to the middle of Mangorewa River; thence generally south-westerly up the middle of that river, to and up the middle of Ohaupara Stream to the south-eastern boundary of Taumata 3A, 2B; thence south-westerly to and along that boundary and the south-eastern boundary of Section 3, Block II, Rotorua Survey District, to its southernmost point; thence north-westerly along the south-western boundary of the said Section 3 to its intersection with a right line between the westernmost corner of Section 9, Block V, Horohoro Survey District, and Trig. Station 27, Puwhenua, at the easternmost corner of Block VII, Tapapa East Survey District; thence north-easterly along that right line to Trig. Station 27; thence north-westerly along a right line to Trig. Station 146, Te Weraiti, at the northernmost corner of Block I, Tapapa East Survey District; thence north-easterly along a right line to Trig. Station 909, Waiuananu, at the easternmost corner of Block XVI, Wairere Survey District; thence along the generally north-eastern boundaries of part Okauia 1 (Gordon Park Scenic Reserve) Mauri-horo A and B, Waiharakeke East part 5, 1A, 1C2B2, 1C1A and part Section 20, Block III, Wairere Survey District shown on D.P. 28359, to the southern boundary of Thompson Track; thence by a right line, to the southernmost point of Section 20 aforesaid, shown on D.P. 4110; thence proceeding generally north-westerly along the generally north-eastern boundaries of that section, another part Section 20 shown on D.P. 26605, another part Section 20 (State Forest, *Gazette*, 1955, page 1892), along the eastern side of a public road to and along the generally north-eastern boundary of Lot 5, D.P. 25781, to its northernmost point; thence north-westerly along the eastern boundary of the original Aroha Block shown on M.L. 3062, being through State Forest in Block X, Aongatete Survey District, and Blocks VII and XI, Katikati Survey District, to the north-western boundary of Katikati Survey District; thence south-westerly along that boundary to Trig. Station 567, Te Aroha, at the westernmost corner of Katikati Survey District; thence north-easterly along a right line to the westernmost corner of Section 3, Block VII, Aroha Survey
