## NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Milk Price Notice 1980.

(2) This notice shall come into force on the 1st day of February 1980.

**2. Interpretation**—In this notice, unless the context otherwise requires,—

“The Act” means the Milk Act 1967;

“Approved association” means an association of milk producers approved under section 53 (1) of the Act;
