

Hamilton Teachers College Council Amendment Notice 1980

"(ee) One member, to be appointed by the Minister of Education on the nomination of the Waikato and Eastern District Regional Branch of the New Zealand Secondary School Boards' Association (Incorporated) and who shall be a member of that Association;"
