

to the northern boundary of Block VII, Tarras Survey District; thence easterly and southerly along the northern and eastern boundaries of the last-mentioned block to the north-western boundary of Section 4, Block X, Tarras Survey District; thence north-easterly, south-easterly, and south-westerly along the north-western, north-eastern, and south-eastern boundaries of the last-mentioned section to its southernmost corner; thence southerly and westerly along the eastern and southern boundaries of Section 12, Block VII, Tarras Survey District, to the easternmost corner of Section 43, Block VII, Tarras Survey District; again westerly along the southern boundaries of that Section 43 and Section 12 aforesaid and the production of the last-mentioned boundary to the easternmost corner of part Section 9, Block VII, Tarras Survey District; thence south-westerly along the south-eastern boundary of the last-mentioned part section and its production to the south-western boundary of the Crown Land intersecting the said part Section 9; again south-westerly along the south-eastern boundary of that same part section 9 and its production to the middle of the Clutha River; thence generally south-easterly down the middle of that river to a point in line with the production of the south-eastern boundary of Section 35, Block VII, Tarras Survey District; thence south-westerly to and along that boundary to the north-eastern side of State Highway No. 6; thence north-westerly along that roadside to a point in line with the production of the eastern boundary of Section 31, Block VII, Tarras Survey District; thence south-westerly to and generally southerly along that boundary to the south-eastern corner of the last-mentioned section; thence generally westerly along the northern boundary of part Run 626 (Queensberry Hills) to its northernmost corner; thence north-easterly along the north-western boundary of part Section 33, Block VII, Tarras Survey District, to the easternmost corner of part Run 631 (Criffel); thence generally westerly along the northern boundary of the last-mentioned part run to the westernmost corner of Kingan Road; thence due west by a right line to the south-eastern boundary of Run 625 (Mid Run); thence generally north-easterly and north-westerly along the south-eastern and north-eastern boundaries of the last-mentioned run to its northernmost corner; thence south-westerly and westerly along the southern boundary of Block VIII, Lower Hawea Survey District, to the south-western corner of the said block; thence northerly along the western boundaries of Block VIII and VI, Lower Hawea Survey District, to the north-eastern side of an unnamed road intersecting Section 9, Block VI, Lower Hawea Survey District; thence generally easterly along the southern boundary of the Lake Hawea Fire District hereinbefore described to the point of commencement.

TWENTY-SIXTH SCHEDULE

DUNEDIN FIRE DISTRICT

ALL that area in the Otago Land District, Silverpeaks County, Saint Kilda, Port Chalmers, Mosgiel, and Green Island Boroughs and City of Dunedin, containing 65,000 hectares, more or less, bounded by a line commencing on the sea coast at the southernmost corner of Block XII, Waikouaiti Survey District, and proceeding generally westerly along the southern boundary of the Waikouaiti Fire District, hereinbefore described to the south-eastern corner of Section 30 (D.P. 2465), Block II, Waikouaiti Survey District; thence westerly along the southern boundaries of the last-mentioned section and Sections 87 and 56, Block II, Waikouaiti Survey District, to the south-western corner of the last-mentioned section; thence south-easterly along the north-eastern side of an unnamed road to a point in line with the western boundary of Section 33, Block II, Waikouaiti Survey District; thence southerly to and along the eastern boundaries of part Section 41, Sections 79, 86, and 80, and part Section 58, Block II, Waikouaiti Survey District, to the northern side of Pullar Road; thence westerly along that roadside to the eastern boundary of Section 113, Block II, Waikouaiti Survey District; thence southerly along the eastern boundary of Section 106, Block I, Waikouaiti Survey District, to the south-eastern corner of the last-mentioned section; thence westerly along the southern boundary of that same Section 106 to the north-eastern corner of Lot 3, D.P. 11313; thence generally southerly along the eastern boundaries of Lots 3 and 4, D.P. 11313, to the north-eastern corner of Section 91, Block I, Waikouaiti Survey District; thence southerly along the eastern boundaries of the last-mentioned section and Sections 18, 105, and again 18, and Section 19, Block I, Waikouaiti Survey District, to the north-western corner of Section 16, Block I, Waikouaiti Survey District; thence easterly along the northern boundary of the last-mentioned section to its north-eastern corner; thence southerly along the eastern boundaries of that

same Section 16, Section 104, and part Section 23, Block I, Waikouaiti Survey District, to the north-western corner of part section 59, Block I, Waikouaiti Survey District; thence easterly along the northern boundaries of the last-mentioned part section, Section 103, again part Section 59 and part Section 60, Block I, Waikouaiti Survey District, to the north-eastern corner of the last-mentioned part section; thence southerly along the eastern boundaries of that same part Section 60, Section 103, again part Section 60, Block I, Waikouaiti Survey District, to the southernmost corner of that part Section 60; thence generally north-westerly along the southern boundary of that same part Section 60 to the eastern boundary of part Section 59, Block I, Waikouaiti Survey District; thence southerly along that boundary to the middle of Careys Creek; thence generally north-westerly and south-westerly up the middle of that creek to its intersection with the North Harbour and Blueskin and Waikouaiti Survey District boundary; thence easterly along that Survey District boundary to the western side of Semple Road; thence generally south-westerly along that roadside to a point in line with the south-eastern boundary of Section 33, Block III, North Harbour and Blueskin Survey District; thence south-westerly to and along that boundary to the westernmost corner of part Section 30 (243.2396 hectares), Block III, North Harbour and Blueskin Survey District; thence generally easterly along the southern boundary of that part Section 30 and the production of the last-mentioned boundary to the south-eastern side of an unnamed road; thence south-westerly along that roadside and its production to the south-western side of another unnamed road passing through Section 24, Block III, North Harbour and Blueskin Survey District; thence generally southerly along that roadside to its intersection with the western side of State Highway No. 1; thence generally southerly along that roadside to its intersection with the north-eastern boundary of part Section 42, Block VIII, North Harbour and Blueskin Survey District; thence north-westerly by a right line to the westernmost corner of Section 40, Block VIII, North Harbour and Blueskin Survey District, and the production of that line to the eastern boundary of Section 80, Block V, Dunedin and East Taieri Survey District; thence south-westerly by a right line to the south-eastern corner of Section 1 of 35, Block IV, Dunedin and East Taieri Survey District, again south-westerly by a right line to the intersection of the south-western boundary of Section 1, Block IV, Dunedin and East Taieri Survey District, with the northern side of Three Mile Hill Road; thence generally north-westerly along that roadside to the westernmost corner of Section 1632R, Block XIII, East Taieri Survey District; thence north-easterly along the north-western boundary of the last-mentioned section to the easternmost corner of part Section 2, Block XIV, East Taieri Survey District; thence north-westerly along the north-eastern boundaries of the last-mentioned part Section, closed road (shown on S.O. 10083), again part Section 2 and part Section 8, Block XIV, East Taieri Survey District to the south-eastern side of Silverstream Valley Road; thence generally northerly along that roadside to the Silverpeaks and Dunedin and East Taieri Survey District boundary; thence generally westerly along that survey district boundary to the middle of the Taieri River; thence generally southerly and westerly up the middle of that river to its confluence with Lee Stream; thence generally northerly and westerly up the middle of that stream to its intersection with the western boundary of Block X, Mount Hyde Survey District; thence southerly along that block boundary to its intersection with the northern side of an unnamed road; thence generally westerly along that roadside and its production to the southern side of State Highway No. 87; thence generally south-easterly along that roadside to the western boundary of part Section 14, Block X, Maungatua Survey District; thence southerly along that boundary and its production to the middle of Whare Creek; thence generally easterly down the middle of that creek to its confluence with an unnamed stream passing through Sections 7, 13 and 19, Block X, Maungatua Survey District; thence generally southerly up the middle of that stream to its intersection with the southern boundary of Section 9, Block X, Maungatua Survey District; thence easterly along that boundary to the western side of Woolshed Road; thence generally southerly along that roadside to its intersection with the northern side of McHendry Road; thence generally south-westerly along that roadside to a point in line with the south-western boundary of Section 22, Block XI, Maungatua Survey District; thence south-easterly to and along the last-mentioned boundary and its production to the southern side of an unnamed road intersection part Section 24, Block XI, Maungatua Survey District; again south-easterly along the south-western boundary of that same Section 22 to the south-eastern boundary of Block XI, Maungatua Survey District; thence south-westerly along that block boundary to the northernmost corner
