range from the realistic and natural to the posed; some are overtly erotic in intention and a few are elaborately contrived. It appears that the author's often asserted interest in examining nude photography as an art has become somewhat confused with a desire to produce sexually exciting spectacle for commercial purposes. The honesty of purpose is, therefore, open to question. However, the emphasis is most often on the naked body without adornment and we do not hold that nudity is in itself corrupting. The Tribunal believes that those with an adult perspective will have no difficulty accepting the collection as a whole, but that young people may have some difficulty. It, therefore, classifies *Private Naked Gallery* as indecent in the hands of persons under 16.
