NOTE—The denomination Heron has been approved for this variety in the United Kingdom, but was not acceptable in New Zealand because the denomination was already used as a synonym for a pea variety of common knowledge. The applicant previously proposed the denomination Auk for the variety (notice No. 2336, in *Gazette*, March 1980), but now proposes the denomination Cygnat.
