AUCKLAND CITY COUNCIL NOTICE OF INTENTION TO TAKE LAND

NOTICE is hereby given that the Auckland City Council proposes under the provisions of the Public Works Act 1928, to take the fee simple estate in the land described in the First Schedule hereto for a certain public work, namely a service lane, and the land described in the Second Schedule hereto for a certain public work, namely a car park.

The general purpose for which the land to be taken is to be used is for a service lane in respect of the land in the First Schedule, and a car park in respect of the land in the Second Schedule.

A plan showing the land required to be taken is deposited in the public office of the Auckland City Council, being numbered 951, and being at the offices of the City Planner, on the Eighth Floor of the Civic Administration Building, Greys Avenue, Auckland, and is there open for inspection.
