10. The powers, functions, duties and authorities conferred on the authority by this order may at any time be resumed by the Governor-General, without payment of any compensation whatever, on giving the authority at least 6 calendar months' notice in writing. Any such notice shall be sufficient if given by the Minister and delivered at or posted to each council at the last known address of the council in New Zealand.
