A PROCLAMATION

PURSUANT to section 330A of the Public Works Act 1928, I, The Right Honourable Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby amend the Proclamation dated the 30th day of April 1980, and published in *New Zealand Gazette*, 15 May 1980, No. 55, at page 1415, declaring land acquired for a local work and not required for that purpose to be Crown land, in Blocks I and IV,
