## A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, The Honourable Sir David Stuart Beattie, the Governor-General of New Zealand, hereby proclaim and declare that a power cable easement in gross is hereby taken for the generation of electricity over the land described in the Schedule hereto, vesting in Her Majesty the Queen, firstly, the full, free and uninterrupted liberty, right, licence, and authority to lay a line of cables for the transmission of electricity through and under the land described in the Schedule hereto, and secondly, the full, free and uninterrupted liberty, right, licence, and authority to enter upon the said land for the purpose of inspecting, repairing, maintaining and renewing of such cables or any parts thereof and of opening up the soil of that land to such extent, as may be necessary or reasonable; and I also declare that this Proclamation shall take effect, on and after the 3rd day of September 1981.
