Standards for Honey to be Exported to Cyprus
(Notice No. 2689, Ag. 12/2/5)

PURSUANT to regulation 5 (1) of the Honey Export Certification Regulations 1980, the Director-General hereby sets the following standards for honey which is to be exported to Cyprus:

1. The apiaries from which the honey is derived shall be free from the diseases: *Bacillus larvae*; *Streptococcus pluton*; *Acarapis woodi*; and *Varroa jacobsoni*.

2. There shall be no incidence of the above-named diseases found within a radius of 5 kilometres of these apiaries during the honey production season in question.
