Import Control Exemption Notice (No. 27) 1981

Pursuant to regulation 17 of the Import Control Regulations 1973\*, the Minister of Trade and Industry hereby gives notice as follows:

- (a) This notice may be cited as the Import Control Exemption Notice (No. 27) 1981.
  (b) This notice shall come into force on the 1st day of January 1982.
- 2. Goods of the classes specified in the First Schedule hereto, imported from and being the produce or manufacture of any country, are hereby exempted from the requirement of a licence under the said regulations.
- 3. The exemption from the requirement of a licence under the said regulations in respect of the goods of the classes set forth in the Second Schedule hereto, included in the exempting notice shown in the Second Schedule is hereby withdrawn.

Classes of Goods

Goods (other than motor vehicles and goods already exempt import licensing control) imported as part of his baggage by a passenger arriving in New Zealand, for the personal use of the importer and not for purposes of sale, business, or for use in the trade, calling or profession of the importer, or on behalf of any other person or persons.
