Prohibition of Hunting, Killing, or Being in Possession of Sambar Deer in the Wanganui, Rangitikei, Manawatu and Horowhenua Counties

PURSUANT to section 8 (3) of the Wild Animal Control Act 1977, the Minister of Forests hereby declares that the hunting, killing, or having in possession of sambar deer, *Cervus unicolor*, in the counties of Wanganui, Rangitikei, Manawatu, and Horowhenua by persons other than Forest Service employees, or persons holding valid permits to retain sambar deer in captivity, is prohibited from and including the 1st day of March 1981, for a period of 5 years expiring on the 29th day of February 1986.
