Conditions: Junior South Island Game Season Licences may be issued to persons up to 16 years of age and shall enable the holder to hunt or kill game in all acclimatisation districts of the South Island. The holder of the licence shall be subject to the conditions and daily possession limits of the acclimatisation district in which the hunting or killing of game takes place of game takes place.

The provisions of the Arms Act 1958 apply with respect to firearms used in accordance with the licence.

These provisions will come into force on the 1st day of April 1981.
