The roads specified in the Second Schedule hereto are hereby declared to be 70 kilometres an hour speed limit areas pursuant to regulation 21 (2) of the Traffic Regulations 1976\*. The Traffic (Paparua County) Notice No. 5, 1978, dated the 11th day of July 1978† and the Traffic (Paparua County) Notice No. 1, 1980, dated the 6th day of June 1980‡, issued pursuant to section 52 of the Transport Act 1962, and regulation 21 (2) of the Traffic Regulations 1976, are hereby revoked.

## FIRST SCHEDULE

SITUATED within Paparua County at Hornby, Sockburn and Upper Riccarton:

thence north-westerly, generally, by a right line at right angles to the south-eastern side of Russley Road to the north-western side of Russley Road; thence south-westerly, generally, along that side of Russley Road to the westerly, generally, along that side of Russley Road to the north-eastern side of the No. 73 State Highway (Christchurch-Kumara); thence north-westerly, generally, along that road-side to a point 120 metres measured along that roadside from Russley Road; thence south-westerly, generally, across the No. 73 State Highway (Christchurch-Kumara) at right angles to its north-eastern side to its south-western side; thence south-westerly, generally, by a right line to a point on the north-eastern side of Buchanans Road 200 metres measured north-westerly, generally, along Buchanans Road from Gilberthorpes Road; thence south-westerly, generally, across Buchanans Road at right angles to its north-eastern side to its south-western side; thence south-westerly, generally, by a right line to a point on the north-eastern side of Roberts Road, 200 metres measured north-westerly, generally, along Roberts Road from Matangi Street; thence south-westerly, generally, across Roberts Road at right angles to its north-eastern side to its south-western side; thence westerly, generally, by a right line to the northern end of Mortlake Street; thence southerly, generally, by a right line to the northern end of Brixton Street, thence southerly, generally, by a right line to a point on the northern side of Waterloo Road, 50 metres measured westerly, generally, along Waterloo Road from Brixton Street; thence southerly, generally, across Waterloo Road at right angles to its northern side to its southern side; thence southerly, generally, by a right line to a point on the north-western side of Foremans Road, 50 metres measured south-westerly, generally, along Foremans Road from Halswell Junction Road; thence south-easterly, generally, across Foremans Road at right angles to its north-western side to its southeastern side; thence north-easterly, generally, along that road-side across Halswell Junction Road to the north-eastern side side across Halswell Junction Road to the north-eastern side of Halswell Junction Road; thence south-easterly, generally, along that roadside to the northern side of the No. 1 State Highway (Awanui-Bluff); thence along that roadside to a point 480 metres measured easterly, generally, along the said State Highway from Halswell Junction Road; thence southerly, generally, across the No. 1 State Highway (Awanui-Bluff) at right angles to its northern side, to its southern side; thence westerly, generally, along that roadside to the eastern side of Halswell Junction Road; thence south-easterly, generally, along that roadside to the north-western side of Shands Road; thence along Shands Road to a point 220 metres measured north-easterly, generally, along Shands Road from Halswell Junction Road; thence south-easterly, generally, across Shands Road Road; thence south-easterly, generally, across Shands Road at right angles to its north-western side, to its south-eastern side; thence along that roadside to the north-eastern side of Halswell Junction Road; thence along that roadside to the north-western side of Springs Road; thence along that roadside to a point 440 metres measured north-easterly, generally, along Springs Road from Halswell Junction Road; thence south-easterly, generally, across Springs Road at right angles to its north-western side, to its south-eastern side; thence along that roadside to the north-western side of Wilmers Road; thence north-easterly, generally, along that side of Wilmers Road to the south-western side of Awatea Road, and along the prolongation of the north-western side of Wilmers Road across Awatea Road to the north-eastern side of Awatea Road; thence easterly, generally, by a right line to a point at the intersection of the south-western side of Haytons Road with the north-western side of Wigram Road; thence north-westerly, generally, along that south-western side of Haytons Road to a point 250 metres measured south-easterly, generally, along a point 250 metres measured south-easterly, generally, along Haytons Road from McAlpine Avenue; thence north-easterly, generally, across Haytons Road at right angles to its south-western side, to its north-eastern side; thence south-easterly, generally, along that roadside to the north-western side of Wigram Road; thence north-easterly, generally, along that side of Wigram Road to the eastern boundary of Paparua County; the state of the capacity country to the thence north-westerly, generally, along that boundary to the commencing point.
