Prior to formal inclusion in Schedule A, interested persons or firms are invited to make representations in support of or against any nominated product or products. The representations should be forwarded to the Secretary, Department of Trade and Industry, Private Bag, Wellington, not later than 27 July 1981, and the appropriate inquiries will be conducted. In those cases where the inquiries result in a decision to include the goods in Schedule A, and where the Australian Government is in agreement, such inclusion will be effected at the earliest practicable date.

Products on which no representations against inclusion in Schedule A have been received by 27 July 1981, will be added to the Schedule effective from 1 July, provided the Australian Government agrees.
