PURSUANT to section 63B (1) of the Forests Act 1949 (as substituted by section 19 of the Forests Amendment Act 1976), I, The Honourable Sir David Stuart Beattie, the Governor-General of New Zealand, hereby set apart the State forest land described in the Schedule hereto as State forest park which shall hereby form part of the Pirongia State Forest Park.
