Television 2: "Eyewitness"

An "Eyewitness" television current affairs programme broadcast on 9 September 1980, examined the result of the East Coast Bays by-election. Mr Dawson objected to the use of what appeared to be random interviews with 3 un-named people because they were not balanced or representative. He said it breached standards of objective journalism

We have viewed a tape of the programme.

In the circumstances of the programme it was not necessary to obtain a number of interviews and present a balanced collection of them. While the purpose of the vox pop is frequently to do just that, in this instance it was to introduce consideration of National Party leadership and to illustrate the views held by some electors.

There was nothing in the introduction to the interviews to suggest they were anything more than examples of the "body of concern" about the leadership. The introduction did not mislead.
