

western end of Ness Valley Road and the western boundary of Section 2, Block IX, Wairoa Survey District, to and easterly, southerly, and westerly along the northern, eastern, and southern boundaries of Lot 1, D.P. 42119, to and westerly along the southern boundary of part Mataitai No. 6 Block comprised in certificate of title 1504/27 and continuing along the northern boundary of Lot 1, Deeds Plan 71 blue to its northernmost corner; thence southerly and easterly along the western and southern boundaries of that Lot 1, to and southerly along the western boundary of Allotment 21, Otau Parish, to and easterly along the northern side of Otau Mountain Road to a point due north of the easternmost corner of Allotment 25, Otau Parish, in Block XII, Wairoa Survey District; thence due south to and westerly along the southern boundary of that Allotment 25 and that boundary produced to a point on the left bank of the Wairoa River; thence southerly along that left bank to the easternmost corner of Allotment 112A, Hunua Parish; thence westerly along the northern boundary of Allotment 112A and Lots 3 and 1, D.P. 78762, to the eastern side of a public road; thence south-westerly, generally, along the eastern side of the public road forming the western boundaries of that Lot 1, Allotments 148, 149, 150, Hunua Parish, and the eastern side of McGregor Road to its intersection in Block I, Opaheke Survey District, with an arc of 8.045 kilometres radius from the easternmost corner of Allotment 206, Section 11, Village of Papakura (Papakura Fire Station); thence south-westerly, generally, along that arc to its intersection with the western boundary of Lot 1, D.P. 19546, in Block VIII, Drury Survey District; thence southerly along a right line to the easternmost corner of Allotment 93, Suburban Section 2, Opaheke Parish, in Block XII, Drury Survey District; thence south-westerly along another right line to a point on the northern boundary of Allotment 362, Opaheke Parish, due south of the southernmost corner of Ambush Road; thence north-westerly along another right line to a point due west of the northernmost corner of Allotment 172, Karaka Parish, on the north-western side of State Highway No. 22 in Block VII, Drury Survey District; thence due north along another right line to the intersection with an arc of 8.045 kilometres radius from the easternmost corner of Allotment 206, Section 11, Village of Papakura (Papakura Fire Station); thence north-westerly along that arc crossing the Whangamaire Creek to its junction with the line of mean high water of the Manukau Harbour in Block XIII, Otahuhu Survey District; thence easterly and northerly, generally, along the line of mean high water of the Manukau Harbour and including the Onehunga wharves, to a point in line with the eastern boundary of Allotment 384, Waikomiti Parish, in Block VII, Titirangi Survey District; thence northerly along a right line across Taunton Terrace to and along that eastern boundary and the southern and eastern boundaries of Allotment 381, Waikomiti Parish, to and westerly along the southern side of Connaught Street to its junction with the eastern side of Portage Road; thence northerly along that eastern side to the southernmost corner of part Allotment 363, Waikomiti Parish (New Lynn Domain Recreation Reserve described in *New Zealand Gazette*, 1979, p. 522), thence north-easterly and northerly along the south-eastern and eastern boundaries of that part Allotment 363, and continuing along the western boundary of Lot 1, D.P. 52190, and that boundary produced to and easterly along the northern side of Heaphy Street to and again northerly along the eastern boundary of the said part Allotment 363 to and westerly along its boundary to the left bank of the Avondale Stream; thence south-westerly, generally, along the said left bank to its intersection with the middle of Portage Road; thence northerly along the middle of Portage Road and westerly along the middle of Golf Road to a point in line with the eastern boundary of Lot 2, D.P. 69086; thence northerly along a right line to and along the eastern boundary of that Lot 2 and the eastern boundaries of Allotments 652, 649, 648, and 704, Waikomiti Parish, along a right line across Grandison Crescent to and along the eastern boundaries of Allotments 688, 690, and 693, Waikomiti Parish, and Lot 1, D.P. 36680, to the westernmost corner of Lot 1, D.P. 46392; thence north-easterly along a right line between that corner and the southernmost corner of Lot 15, D.P. 10738, to the middle of Arahoe Road and northerly along that middle line to and south-westerly along the middle of Hutchinson Avenue and the last middle line produced to the south-western side of Barker Avenue; thence north-westerly along the south-western side to and south-westerly along the south-eastern boundaries of Lots 7 and 6, D.P. 40481, and north-westerly along the north-eastern boundary of Lot 6, D.P. 64801, along a right line to and along the north-eastern boundaries of Lot 3, D.P. 64801, and Lot 1, D.P. 10388, along a right line across West Lynn Road to and along the north-eastern boundaries of Lots 7 and 5, D.P. 39449, and Lot 9, D.P. 23375 (Plantation Reserve), along a right line across Titirangi Road to and along the south-western boundary of Allotment 139, Waikomiti Parish, to its westernmost corner in Block III, Titirangi Survey District; thence north-easterly

along the north-western boundaries of Allotments 139 and 140, to the northernmost corner of Lot 1, D.P. 44544 and along a right line to the junction of the north-eastern side of Croydon Road with the middle of Fruitvale Road and along that middle line to a point in line with the south-western boundary of Allotment 159, Waikomiti Parish; thence north-westerly along a right line to and along that south-western boundary to and north-easterly along the south-eastern boundaries of Lots 26, 25, 24, 23, and 22, D.P. 20071, crossing the intervening Tahurangi Terrace, to the easternmost corner of that Lot 22; thence along a right line bearing 288°01' 83.17 metres distance and north-easterly along a right line to and along the north-western boundaries of Lots 3, 2 and 1, D.P. 76570, and the last boundary produced to the middle of Great North Road; thence south-easterly along that middle line to and north-easterly along the middle of Lynwood Road to a point in line with the north-eastern boundary of Allotment 196, Waikomiti Parish; thence north-westerly along a right line to and along that north-eastern boundary and north-easterly along the south-eastern boundaries of Allotment 198, Waikomiti Parish, Lot 2, D.P. 31889, and Lot 23, D.P. 47198, a right line across Rimu Street to and along the south-eastern boundaries of Lots 9, 5, and 4, D.P. 47198, Lot 2, D.P. 62445, Lots 2 and 1, D.P. 47198, Lots 10, 9, 8, 7, 6, 5, 4 and 3, D.P. 43457, and Lot 16, D.P. 43825, along a right line across Alston Avenue to the easternmost corner of Lot 19, D.P. 43825, and along the north-western boundary of Lot 20, D.P. 43825, to and south-easterly along the north-eastern boundaries of that Lot 20 and Lot 21, D.P. 43825, to the point of commencement including Puketutu Island and the Auckland Metropolitan Drainage Works ponding areas, Pollen, Browns, Wiroa, Shark, Motukaraka Island and all other adjacent islands in adjoining inlets and creeks but excluding Lot 2, D.P. 50858 and Papatoetoe City described in *New Zealand Gazette*, 1960, p. 1058, and all that area in the North Auckland Land District, Rodney county, Takapuna city, East Coast Bays city, Birkenhead city, Devonport borough, and Northcote borough, bounded by a line commencing at the junction of the line of mean high water of the Okura River and the southern boundary of part Lot 1, D.P. 51511, in Block XV, Waiwera Survey District, and proceeding westerly along the southern boundary of part Lot 1, D.P. 51511, and that boundary produced across the East Coast road to the easternmost corner of Allotment 87, Okura Parish; thence southerly and westerly generally along the eastern and southern boundaries of the aforesaid allotment and the south-eastern boundary of Lot 2, D.P. 70015, and that boundary produced across Bawdens Road and north-westerly along the north-eastern boundary of Allotment 206, Pukeatua Parish, to its northernmost point; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of Allotment 205 and the south-western boundary of Allotment 202 to and south-westerly and north-westerly along the south-eastern and south-western boundaries of Allotment 200 and the south-western boundary of Allotment 199 to Bawdens Road; thence along a right line across Bawdens Road to the southernmost corner of Lot 11, D.P. 65853, and north-westerly along the south-western boundaries of Lots 11 and 10, D.P. 65853, and the south-western boundary of part Allotment 198, Pukeatua Parish, to Postmans Road; thence south-westerly generally along the generally south-eastern side of Postmans Road to and south-easterly along the north-eastern side of State Highway No. 1 to its junction with the eastern boundary of part Allotment 415, Pukeatua Parish; thence southerly along a right line across State Highway No. 1 to the northernmost point of Allotment 331, Pukeatua Parish; thence southerly along the western boundary of Allotment 331, Pukeatua Parish, to and south-westerly generally along the right bank of Dairy Stream to its junction with the left bank of the Rangitopuni Stream; thence along a bearing of 225° to the right bank of the Rangitopuni Stream and southerly generally along that right bank to its junction with the left bank of Walsh Creek in Block II, Waitemata Survey District; thence south-westerly generally along that left bank to its intersection with the north-eastern boundary of Allotment 218, Paremoremo Parish, and along the north-eastern and north-western boundaries of that Allotment; thence along a right line across the aforementioned legal road to the westernmost corner of Lot 2, D.P. 15622, and easterly and southerly along the northern and eastern boundaries of
