

*Notice of Intention to Vary Hours of Sale of Liquor at
Licensed Premises—Nelson Licensing Committee*

PURSUANT to section 221A of the Sale of Liquor Act 1962, as amended by section 22 (14) of the Sale of Liquor Amendment Act 1976, I, John Fraser Robertson, Secretary for Justice, hereby give notice that the Nelson Licensing Committee on 22 June 1981, made an order authorising variations of the usual hours of trading for the licensed premises known as the Star and Garter Hotel, Nelson.

To the intent that on days other than those on which licensed premises are required to be closed for the sale of liquor to the general public the hours for the opening and closing of the said premises shall be as follows:

During the period 1 November to 31 March and pertaining to the lounge bar only:

- (a) On any Thursday and Saturday (not being New Year's Eve) and on Christmas Eve—Opening at 11 o'clock in the morning and closing at 11 o'clock in the evening.
- (b) On any New Year's Eve—Opening at 11 o'clock in the morning and closing at 00.30 o'clock on the morning of New Year's Day.
