Land Taken for Road in the City of Auckland

DAVID BEATTIE, Governor-General A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, The Honourable Sir David Stuart Beattie, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for road and shall vest in the Auckland City Council as from the date hereinafter mentioned; and I also declare that this Proclamation shall take effect on and after the 14th day of January 1982.

SCHEDULE

NORTH AUCKLAND LAND DISTRICT

ALL that piece of land containing 9 square metres, situated in the City of Auckland, being part Lot 1, D.P. 3157; as shown on plan S.O. 55514, lodged in the office of the Chief Surveyor at Auckland, and thereon marked "A".

Defining the Middle Line of Portions of the Timaru-Mitton

State Highway in the County of Vincent DAVID BEATTIE, Governor-General A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, The Honourable Sir David Stuart Beattie, hereby proclaim and declare that the middle line of portions of road desired to be continued in the County of Vincent, viz., a relocation of the Timaru-Milton State highway shall be that defined and set forth in the Schedule hereto; and I also declare that this proclamation shall affect only the land situated within the limits of the areas shown shaded on plan S.O. 20061 referred to in the Schedule hereto.

SCHEDULE

OTAGO LAND DISTRICT

Commencing at a point on the centre line of State Highway No. 6 and distant 10.59 metres due west of the northern boundary of Section 4, Block IV, Wakefield Survey District (generation of electricity GN 520187), and thence proceeding in a generally south-westerly direction for a distance of 5800 metres approximately, passing in, into, through or over the following land, viz. described in sequence; State Highway No. 6, Section 53 (generation of electricity GN 520187), part Section 3 (generation of electricity GN 520187), again over the said State Highway No. 6 and part Section 3, Section 2 (licence LG 671), all being situated in Block IV, Wakefield Survey District; Section 43 (CL 7A/261), Block V, Cromwell Survey District; an unnamed road (legal road vested in Vincent County), part Lot 3, D.P. 3318 (generation of electricity GN 496729) all within Block V, Wakefield Survey District; Lot 1, D.P. 5674 (generation of electricity GN 496729), Section 57 (reserved as a site for public hall and athenaeum, *Gazette*, 1907, p. 450), an unnamed road (legal road vested in Vincent County), Section 80 (CT 217/37), Lot 3, D.P. 15233 (CT 5D/409), Bilton Road (vested in Vincent County), part Section 1, Sunnyside Subdivision (CT 8C/1231), Lot 1, D.P. 17171 (CT 8C/1230), Section 2, Sunnyside Subdivision (CT 5D/806), Section 53 (CT 136/219), and State Highway Nos. 6 and 8 (common route), all being situated in Block III, Cromwell Survey District; and terminating at a point being the northernmost corner of Section 41 (CT 86/68), Block III, Cromwell Survey District; all situated in Vincent County as the same is more particularly delineated on a plan numbered S.O. 20061, lodged in the office of the Chief Surveyor at Dunedin.
