PURSUANT to section 11 of the Plant Varieties Act 1973, notice is hereby given that applications for grants of Protective Direction and grants of Plant Selectors' Rights, as specified in the Schedule hereto, have been received by the Registrar of Plant Varieties. If any person considers that he is likely to be unfairly affected by the applications for grants of Protective Direction and Grants of Plant Selectors' Rights, he may lodge an objection with the Registrar within 2 months from the date of this *Gazette*. Objections must comply with section 19 of the Plant Varieties Act 1973.
