## DAVID BEATTIE, Governor-General A PROCLAMATION

Pursuant to the Public Works Act 1981, I, The Honourable Sir David Stuart Beattie, the Governor-General of New Zealand, hereby revoke the Proclamation dated the 5th day of June 1970, and published in the Gazette No. 34, of 11 June 1970, at page 1010, taking land for the Tauranga - Te Maunga motorway, in so far as it affects the land described in the Schedule hereto, such land being no longer required.
