*Environmental Impact Report Notified—Proposed Mimiwhangata Marine Park, Northland*

THE Commission for the Environment has received an Environmental Impact Report prepared for the Hauraki Gulf Maritime Park Board and the Mimiwhangata Farm Park Charitable Trust on a proposal to establish a marine park at Mimiwhangata.
