Notice Setting Out Amendments to the Requirements for the Importation of Seeds, Stockfood and Related Dried Preserved Products (Notice No. 2374, Ag. 12/2/21)

PURSUANT to the Introduction and Quarantine of Plants Regulations 1973 and the Stock Foods and Agricultural Seeds Importation Regulations 1958, the Director-General of Agriculture and Fisheries hereby gives the following amendment notice.

At pages 4 and 5, Schedule A, column 6 (Limited to Cultivar), *delete* the term 'Acceptable' and *replace* with 'No' for the following entries:

1. This notice may be cited as the Road Classification (Takapuna City) Notice No. 1, 1982.

2. The Takapuna City Council's proposed classification of the roads as set out in the Schedule hereto is hereby approved.

3. The notice dated the 7th day of February 1979†, which relates to the classification of the roads described in the Schedule hereto is hereby *revoked*.

Esmonde Road: from Barrys Point Road to Lake Road.

Forrest Hill Road: from Wairau Road to the East Coast Bays City boundary.
