*Oxford Recreational Hunting Area*

PURSUANT to section 27 of the Wild Animal Control Act 1977, the Director-General of Forests hereby gives notice that an area of approximately 21 400 hectares, being all of Oxford State Forest and part of Mount Thomas State Forest as shown on plan L34/8 deposited in the Head Office of the New Zealand Forest Service at Wellington, and with the Conservator of Forests at Christchurch, shall form a recreational hunting area where the hunting of red deer, chamois and pigs as a means of recreation shall be used to control (though not exclusively) the number of those animals.

The area shall be known as the Oxford Recreational Hunting Area.

## NOTES

1. No commercial hunting is allowed, except for the taking of possums under Forest Service permit, or on the direction of the Conservator of Forests.

2. The greatest care must be exercised at all times with fires. Fires shall be permitted only in huts, camps, or fire-places provided or built expressly for that purpose. All fires must be in safe places and properly extinguished before being left.

Only dead wood should be used for fuel. Any person responsible for fires getting out of control may be held liable for damage caused and for expenses incurred in firefighting in addition to any fines imposed.

The extent and location of any wild fire is to be reported immediately to a forest officer. In a time of high fire risk as determined by the Conservator of Forests, the area under exotic management in Oxford State Forest may be unconditionally closed as Recreational Hunting Area.
