The Invercargill City Council Foreshore Control Order 1982

ORDER IN COUNCIL

At the Government House at Wellington this 26th day of October 1982

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 165 of the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and Commencement—(1) This order may be cited at the Invercargill City Council Foreshore Control Order 1982.

(2) This order shall come into force on the 1st day of December 1982.

2. Interpretation—In this order—

"The Act" means the Harbours Act 1950:

"The Council" means the Invercargill City Council constituted under the Local Government Act 1974:

"Foreshore" means such parts of the bed, shore or banks of a tidal water as are covered and uncovered by the ebb and flow of the tide at ordinary spring tides.

3. Grant of Control—There is hereby granted to the Council for a period of 21 years commencing with the 1st day of December 1982 and ending with the 30th day of November 2003 control of the foreshore described in the Schedule to this order.

4. Conditions of Grant—The grant of control conferred by clause 3 of this order is subject to the following conditions—

(a) Suitably worded signs shall be erected at main public access ways to the foreshore described in the Schedule to this order indicating that control of the foreshore has been granted to the council pursuant to section 165 of the Act.

(b) All money received by the Council in the performance or exercise of the functions, duties, or powers conferred on it by this order in respect of the foreshore to which this order applies, shall, after the deduction of any expenditure incurred by the Council in the performance or exercise of those functions, duties, or powers, be applied to the construction, repair or improvement of facilities in respect of that foreshore and not otherwise.

SCHEDULE

ALL that area of foreshore commencing at a point at high water mark on the southern bank at the mouth of the Waimatuku Stream thence in a southerly direction to the mouth of the New River Harbour at its northern shore, thence into the New River Harbour and Oreti River upstream to Dunns Road Bridge and the Waihopai River upstream to the Railway Bridge, thence to the mouth of New River Harbour at the southern shore, thence westerly and southerly to Barracouta Point but excluding therefrom any endowment
