

*Land and Easements Taken For Water Supply Purposes in Block XIII, Opaheke Survey District, Franklin County*

A PROCLAMATION

PURSUANT to the Public Works Act 1981, I, The Honourable Sir David Stuart Beattie, the Governor-General of New Zealand, declare the land described in the First Schedule hereto, to be taken for water supply purposes and an easement of right to lay and maintain a pipeline with all accessories and to conduct water through the same and to enter for the purpose of inspecting, repairing, and maintaining the said pipeline to be taken over the land firstly and secondly described in the Second Schedule hereto, and an easement of right of way and an easement of right to lay and maintain a pipeline with all accessories and to enter for the purpose of inspecting, repairing, and maintaining the said pipeline to be taken over the land thirdly described in the Second Schedule hereto and an easement of right of way to be taken over the land fourthly described in the Second Schedule hereto, which land and easements shall vest in The Franklin County Council on the 14th day after the date of the publication of this Proclamation in the *Gazette*.
