This draft amendment will place on record the declaration of IEC 598-2-3 and give details of data which lantern manufacturers are required to provide.

The current New Zealand specification for electric luminaires (lighting fittings) is NZS 6741:1979. This is BS 4533: 1971-72 which will be superseded by a later edition in 1983, based on IEC Publication 598: Luminaires.

As there will need to be an overlap period before NZS 6741:1979 (BS 4533) can be withdrawn, it is proposed to declare IEC 598 under the number NZS 6705.
