*Notice Declaring the Taking of Rock Oysters in Kawhia, Aotea, Raglan, and Kaipara Harbours to be Lawful (Notice No. 2935, Ag. 9/2/1/17)*

PURSUANT to regulation 13 (2) of the Oyster Fishing Regulations 1946, notice is hereby given that the taking of rock oysters shall be lawful in the following specified places between 2 December 1982 and 30 April 1983.

(a) KAWHIA HARBOUR

ALL those waters of the harbour inside of a straight line drawn from the northernmost extremity of Urawitiki Point on the southern entrance to Tauratahi on the northern entrance.

(b) AOTEA HARBOUR

ALL those waters of the harbour inside of a straight line drawn from Kahua Point to Potahi Point.

(c) RAGLAN HARBOUR

ALL those waters of the harbour inside of a straight line drawn from Rangitoto Point to the northernmost end of Ngarunui beach.

(d) KAIPARA HARBOUR

ALL those waters of the harbour inside of a straight line drawn from South Head to Kaipara Head but excluding all Maori oyster fisheries and the following waters:

- (i) All those waters inside a straight line drawn from Te Whau Point to Plunket Point;
- (ii) All those waters above the railway bridge across the Kaiwaka and Wairau Rivers;
- (iii) All those waters inside a straight line drawn from the southernmost extremity of Pahi Peninsula then to the northern point of Kerikeri Inlet then to Page Point;
- (iv) All those waters inside a straight line drawn from Aotea Cliffs to Oyster Point.
