An easement in gross over and along the land secondly described in the Third Schedule hereto for the full and free right for The Tauranga City Council, The Tauranga Electric Power Board and The Tauranga Joint Generation Committee by their respective agents, employees, engineers and contractors in common with Arthur Ballantyne Scott and his successors in title from time to time and at all times by day and by night forever hereafter to pass and re-pass on foot with or without such tools or equipment as those persons may require to main and protect the electricity works on the Mangakarengorengo River and generally for all purposes connected with and enabling The Tauranga City Council, The Tauranga Electric Power Board and The Tauranga Joint Generation Committee to police and carry into effect The Tauranga Joint Generation Committee's policy from time to time for the management and control of the diversion of the waters of the Mangakarengorengo River into Lake McLaren.
