- 3. In this bylaw the expression "heavy motor vehicle" has the meaning assigned to it in the Transport Act 1962.
- 4. No person shall take or drive any heavy motor vehicle or combination of heavy motor vehicles on to the Waitangi-Taona (Waitangi) River Bridge at R.P. 584/0.00 on No. 6 State Highway (Blenheim-Invercargill) while there is another heavy motor vehicle or combination of heavy motor vehicles on that bridge.
- 5. Every person who commits an offence against this bylaw is liable on summary conviction to a fine not exceeding two hundred dollars (\$200).
