

thence south-easterly, generally, by a right line to the western terminating point of Puriri Avenue; thence southerly, generally, by a right line to a point on the southern side of West Hoe Road 40 metres measured westerly, generally, along West Hoe Road from Centreway Road; thence south-westerly, generally, by a right line to the western terminating point of Florence Avenue; thence southerly, generally, by a right line to the western terminating point of Riverside Road; thence southerly, generally, by a right line across the Orewa River to the western terminating point of Moffats Road; thence south-easterly, generally, along the south-western side of Moffats Road to its intersection with the No. 1 State Highway (Awanui-Bluff); thence south-easterly, generally, across the said State highway from its north-western side to its south-eastern side; thence south-westerly, generally, along the south-eastern side of the said State Highway to its intersection with Whangaparaoa Road; thence easterly, generally, along the northern side of Whangaparaoa Road to a point due north of the western side of Chenerys Road; thence due south by a right line to the northern bank of the Weiti River; thence south-easterly, generally, along the said bank of the said river to the shoreline of the Hauraki Gulf; thence north-easterly, generally, along the said shoreline to a point due south of the eastern terminating point of Matakatia Parade; thence north-westerly, generally, by a right line to a point where the south-western side of Roberts Road intersects the south-eastern side of Whangaparaoa Road; thence due west across Whangaparaoa Road by a right line to the shoreline of the Hauraki Gulf; thence westerly, generally, along the said shoreline across the outlet of the Orewa River to the commencing point.

No. 1 State Highway (Awanui-Bluff): from a point 60 metres measured southerly, generally, along the said State highway from Beach Road to a point 40 metres measured northerly, generally, along the said State highway from Florence Avenue.

SITUATED within Rodney County:

At Huapai and Kumeu:

No. 16 State Highway (Auckland-Wellsford): from Trigg Road, Huapai, to the bridge at a point 200 metres measured south-easterly, generally, along the said State highway from the entrance to Kumeu Railway Station.

Access Road: from the No. 16 State Highway (Auckland-Wellsford) to a point 480 metres measured south-westerly, generally, along the said road from the said State highway.

Matua Road: from the No. 16 State Highway (Auckland-Wellsford) to Orahua Road.

Oraha Road: from the No. 16 State Highway (Auckland-Wellsford) to a point 160 metres measured north-easterly, generally, along the said road from Matua Road.

Riverhead Road: from the No. 16 State Highway (Auckland-Wellsford) to a point 120 metres north-westerly, generally, along the said road from Koroha Road.

Station Road: from the No. 16 State Highway (Auckland-Wellsford) to a point 480 metres measured southerly, generally, along the said road from the said State highway.

Tapu Road: from the No. 16 State Highway (Auckland-Wellsford) to a point 400 metres measured northerly, generally, along the said road from the said State highway.

Trigg Road from the No. 16 State Highway (Auckland-Wellsford) to a point 480 metres measured southerly, generally, along the said road from the said State highway.

At Kaukapakapa:

No. 16 State Highway (Auckland-Wellsford): from a point 160 metres measured northerly, generally, along the said State highway from North Crescent to a point 560 metres measured south-easterly, generally, along the said State highway from the said crescent.

At Riverhead:

All that area bounded by a line commencing at a point on the northern side of the No. 18 State Highway (Brighams Creek-Albany) at the western end of the bridge across the Rangitopuni Creek; thence across the said State highway at right angles from its northern side, to its southern side; thence southerly, generally, along the western bank of the said creek to a point opposite the southern side of the Kaipara Portage Road; thence westerly, generally, along the said roadside to the eastern side of the said State highway; thence across the said State highway, at right angles from its eastern side, to its western side; thence across Riverhead Road, at right angles
