A PROCLAMATION

PURSUANT to subsection (6) of section 5 of the Education Lands Act 1949, I, The Honourable Sir David Stuart Beattie, Lands Act 1949, I, The Honourable Sir David Stuart Beattie, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto, being an area vested in the South Auckland Education Board as a site for a school, shall be vested in Her Majesty the Queen, freed and discharged from every educational trust affecting the same, but subject to all leases, encumbrances, liens, or easements affecting the same at the date hereof.

SOUTH AUCKLAND LAND DISTRICT—THAMES-COROMANDEL DISTRICT

1618 square metres, more or less, being Lots 369 to 372 and 369A to 372A inclusive, D.P. 2000, situated in Block IV, Thames Survey District. All certificate of title, Volume 319, folio 220.

 - (a) All the provisions of every award and agreement that would otherwise apply to persons employed in that workshop; and
 - (b) The Minimum Wage Act 1945, the Holidays Act 1981, and section 10 (2) (b) of the Factories and Commercial Premises Act 1981.
