Commerce Act 1975

NOTICE is hereby given of decision No. 65A of the Commerce Commission dated 18 May 1982. By this decision the Commerce Commission revokes the Order contained in its decision No. 65 dated 24 February 1982 and orders in substitution and pursuant to section 24 of the Act:

"That Wilson and Horton Limited discontinues the practice of refusing to supply Direct Contact Limited, and any of its authorised agents, the service of publishing in the *New Zealand Herald* advertisements relating to real estate, in accordance with the instructions of Direct Contact Limited, or any of its authorised agents, at the prices and on the usual commercial terms and conditions prescribed by Wilson and Horton Limited for the publishing of classified real estate advertisements and further orders that, if requested by Direct Contact Limited, the advertisements placed by it be inserted in the appropriate category of those classifications which are set aside and used for classified real estate advertisements.
