- 2. Except as provided in subclause 1 hereof, this part applies with respect to all goods or services specified in the Schedule hereto being goods or services that have been declared under Part I of this notice.

PROHIBITION OF SALE

3. Subject to the provisions of clause 4 hereof, the sale by any person whomsoever of any goods or services to which this part applies is hereby prohibited.

PROVISION FOR WITHDRAWAL OF PROHIBITION

- 4. The prohibition of the sale by any person of any goods or services in accordance with this notice shall be deemed to be withdrawn with respect to those goods or services:
 - (a) If and when a price order issued pursuant to section 89 of the Commerce Act 1975 comes into force with respect to the goods or services; or:
 - (b) If and when a maximum selling price with respect to the goods and services has been authorised by a special approval pursuant to section 90 of the Act.
