PURSUANT to section 2 of the Canterbury Museum and Library Ordinance 1870, section 26 of the Acts Interpretation Act 1908, as set forth in the Second Schedule to the Acts Interpretation Act 1924, and section 4 of the Canterbury Public Library Act 1948, His Excellency the Governor-General, acting by and with the advice of the Executive Council, hereby makes the following order:

ORDER

1. Title and commencement—(1) This order may be cited as the Canterbury Public Library Order 1982.

(2) This order shall come into force on the day after its notification in the *Gazette*.

2. Sale of Land—(1) The Christchurch City Council is hereby authorised to sell the land described in the Schedule to this order.

(2) The proceeds of the sale of the said land shall be applied for the purposes of a public library.
