In decision No. 926 the Tribunal said:

"In submissions to us reference was made to decisions 432-435 in March 1972. While we adhere to the general principles there set out, the Tribunal considers that there has been some change in the standards of community opinion since then."

Opportunity has been taken to compare the contents of Sexual Pleasures from A to Z with those of Sex Encyclopedia. While it must be said that the former book is of greater length than the latter and while it is true that some matters are more explicit than others, the Tribunal is of the opinion that there is not such a wide difference in the two publications to warrant a different classification. Furthermore, there can be no doubt with the fact that community standards have varied greatly since 1976. The book is classified as indecent in the hands of persons under the age of 18.
